**REFUNDABLE DEPOSIT**

This deposit is refundable at the end of the term the child leaves the School, provided the required period of **ONE FULL TERM'S NOTICE HAS BEEN GIVEN TO THE SCHOOL IN WRITING AND ALL SCHOOL FEES ARE PAID UP.**

**TUITION FEES**

Payment of Tuition Fees are per Term (x 4 Terms per academic year, starting January of each year). Tuition fees are to be paid **in full on or before the first day of each term** and **will be payable in the subsequent term if one full Term's notice has not been given, in writing, to the School. The School reserves the right to charge interest on overdue accounts.**

- Fees paid annually receive a 6% reduction if paid into the School's Account **by 20 January 2012.**
- Second and subsequent younger siblings receive a fee reduction of 10% per child.
- Fees paid monthly (**by arrangement only**) as per table below.

**ADDITIONAL COSTS**

**EXAM FEES** for IGCSE2 and IB1 and IB2 Diploma students writing External Cambridge and International Baccalaureate Exams are an **ADDITIONAL COST** as set down by Cambridge University and the International Baccalaureate Organisation and will vary, depending on the number of subjects and the level at which your child is writing, as well as the exchange rate at the time of writing exams.

Parents will be responsible for External Examination Fees, Stationery, Residential Visits, Camps and Specialist Co-curricular Activities (e.g., fencing, indoor rock climbing, judo, scuba diving, etc.) held during the academic year.

Textbooks and textbook costs for IB (International Baccalaureate) candidates are **not included** in the tuition fees. However, tuition fees are inclusive of textbooks that support the Cambridge Curriculum.
